

## **COLLECTION NOTICE**

## **Dental Services**

St John Ambulance Western Australia Limited (ACN 165 969 406) and its related bodies corporate Apollo Health Limited (ACN 159 660 036) ('We') have legal obligations under the *Privacy Act 1988* (Cth) and the *Australian Privacy Principles* to protect your personal information. This Collection Notice explains how we hold, use, and disclose your personal information (including your health and sensitive information) and how you can access it. We may update and amend this Collection Notice from time to time to reflect changes in legislation, industry codes or our services.

We collect your personal information when you register as a patient with us and use our services, or receive it from third parties, such as your referring health care provider or insurer.

The primary purpose why we collect your personal information is:

- to provide services to you, to provide high quality care, and to fulfil our obligations as required by law;
- for administrative functions associated with our services including appointments, record-keeping, billing, claims processing, referrals or requesting reviews to improve our services.

We may also collect your personal information for the secondary purpose of research or statistical activities relevant to public health; or for the management, funding or monitoring of a health service.

We may disclose all or part of your personal information to:

- you or your legal guardian or approved care giver, as requested by you, or required by law;
- other healthcare providers who support your health care management, for example when referring for pathology, radiology, dental specialists or related services
- organisations who conduct dental research, public health or clinical data linkage organisations as part of an ethics committeeapproved research project in compliance with the National Health and Medical Research Council guidelines, legislation, government agency or regulatory, directions and guidelines.

We may use your personal information to contact you to provide anonymous feedback on your experience with our services, however, your participation is optional. We may ask you to leave an optional review to help others find our services or ask if you would like to receive information about other services we provide, e.g. GP services, urgent care or first aid training.

Your personal information can only be accessed via authorised Team Members with appropriate access and security measures in place. If you choose not to provide your personal or health information, we will be limited in providing services to you.

You have a right to access any personal information we hold about you.
